Registration for summer camp will initially be BY MAIL ONLY beginning March 1. We will accept walk-in registration at 6:00 a.m. on Wednesday, March 3. Make sure that your mail-in registration is **NOT** postmarked prior to March 1.

Initially, registration for Summer Camp will be BY MAIL ONLY.

Please read the following carefully.

- 1) Completely fill out the attached application. Make sure you check the correct term and date.
- 2) Insert the application and a check for **\$100 per term per child** in a regular sized envelope with the following address:

- 3) **DO NOT MAIL ANY EARLIER THAN MARCH 1.** If your application is postmarked prior to March 1, it will be held until March 43rd for processing.
- 4) **Stamped, First Class Mail ONLY. NO METERED MAIL OR SPECIAL DELIVERY.**
- 5) Camp applications will be strictly processed in the order in which they are received in the mail. All Day, Switch Camp and Afternoon Sport Camp are balanced with an equal number of boys and girls.
- 6) Crenshaws will begin notifying everyone after March 15 as to whether or not their application was accepted. Please wait to be contacted.
- 7) Beginning Wednesday, March 3 at 6:00 a.m., we will accept walk-in registration for all remaining openings in the Summer Camp Programs.
- 8) **The balance of your child's tuition will be due in full 15 days prior to the start of camp.** You will get a reminder in the mail about 30 days prior to camp. Failure to pay the balance on time will mean that you forfeit your child's place in camp.
- 9) We use our waiting list during the summer. If your child does not get into camp, you can pay a \$25 fee to be on the list. If your child gets into camp, the \$25 will be used as credit. If not, we will hold the fee for a period of up to one year for use in our other programs.
- 10) If your child is accepted into any of our summer camp programs, **your deposit is completely non-transferable or non-refundable.**
- 11) If your child does not get into our summer camp, your deposit will be returned in full.

ALL DAY CRENSHAW SUMMER CAMP for children ages 5-7 years

Parents drop off and pick up at Crenshaws. This camp is geared towards older children as the day is full and the activities tend to be more physical. The hours are from 7:30 a.m. until 6:00 p.m. daily with scheduled activities beginning at 8:30 a.m. Children bring their own lunch but are provided morning and afternoon snacks.
