Crenshaws Summer All Day & Switch Camp Program Registration

Registration for our FULL Day Camps will initially be **BY MAIL ONLY** beginning March 1.

Make sure that your mail-in registration is **NOT** postmarked prior to March 1.

We will accept walk-in registration beginning 6:00 a.m. on Wednesday, March 6th.

Initially, registration for FULL Day Camp Programs will be **BY MAIL ONLY.**

Please read the following carefully. Failure to follow registration instructions may result in your child not getting into the desired program.

- 1) Completely fill out the attached application. Make sure you check the correct term(s) and date(s).
*We use **Email** a great deal, make sure it is easy to read and correct on the application.*
- 2) Insert the application and a check for **\$100 per term per child** in a regular sized envelope. Include "2019 Summer Full Day Camp Registration" in our address.
- 3) If your application is postmarked prior to March 1, it will be held until March 6th for processing. **Do not mail prior to March 1.**
- 4) **Stamped, First Class Mail ONLY. NO METERED MAIL OR SPECIAL DELIVERY.**
- 5) Beginning Wednesday, March 6th at 6:00 a.m., we will accept walk-in registration for any remaining openings in our Full Day Camp programs. These application will go in after the mail is received on the 3rd.
- 6) **The balance of your child's tuition will be due in full about 15 days prior to the start of camp.** You will get a reminder in the mail about 30 days prior to the start of the term.
- 7) If the program you desire is full, you will be contacted and given the opportunity to place your child on our waiting list at no charge. **Your deposit check will be returned if your child does not get into our summer program.**
- 8) If your child is accepted into any of our summer camp programs, **your deposit is completely non-transferable or non-refundable.**

(Special Note:)

Registration for our Fall After School Program starts on March 5 by mail only. If you are considering registering for our Fall 2019 After School Care Program, please use a separate envelope . Please do not mail prior to March 5th. (We pick up at Highland Park and Doss Elementary Schools.)

ALL DAY CRENSHAW SUMMER CAMP for children ages 5 1/2 -7 years

This program is geared towards younger school-aged children. Activities include arts & crafts, gym, inside/outside games, field trips, swim lessons and free swim. Children bring their own lunch but are provided morning and afternoon snacks. The hours are from 7:30 a.m. until 6:00 p.m. daily with scheduled activities beginning at 8:30 a.m. This camp has a limited enrollment.



SWITCH CRENSHAW CAMP for children ages 7-10 years

This camp is a fast-paced, fun and exciting summer camp program. At Crenshaws, activities include gymnastics, crafts and outside time at the park next door. Two mornings a week, the campers will switch to our Elsass Westlake facility. Activities there include archery, swim, gym and inside/outside games. Parents drop off and pick up at Crenshaws. This camp is geared towards older children as the day is full and the activities tend to be more physical. The hours are from 7:30 a.m. until 6:00 p.m. daily with scheduled activities beginning at 8:30 a.m. Children bring their own lunch but are provided morning and afternoon snacks. We strive to provide children with the most in summer fun. This camp has a limited enrollment.
